**Old Business:** The Scorekeeper starts a discussion regarding the migration of the league website to a new host. The Secretary and Scorekeeper will get this move completed by the next meeting and report.

**New Business:** The Treasurer starts a discussion regarding the GICs and advises the Board that he will hold off until February before taking any actions with them.

The Treasurer starts a discussion regarding COVID-19 and asks if any further information has been made available by the MLHU. The President advises that no further information has been provided to him and we are to continue as we currently are.

The Treasurer starts a discussion regarding mask issues on Thursday nights and advises the Board that he has witnessed multiple people not abiding by the requirements to wear them or wearing them incorrectly while at the line throwing or chalking. After a lengthy discussion it is decided and agreed upon by the Executive that should we see people not wearing them correctly we are to warn the offenders and advise them they need to be worn properly.

**Complaints/Issues:** The President starts a discussion regarding a verbal altercation between Chad M. and Collin M. After a lengthy discussion which involved witness accounts and communication from both parties via phone or email a motion is put forward by the President to issue a written warning and a one week suspension as time served to Chad M. with emphasis that further issues may result in a suspension for the remainder of the season with the possibility of expulsion or both. This is seconded by Director Dave with 2 For, 4 Against and 1 Abstaining and does not pass. After further discussion a motion is put forward by Director Ken to issue a written warning and a two week suspension to Chad M. with emphasis that further issues may result in a suspension for the remainder of the season with the possibility of expulsion or both. This is seconded by Director Ed with 6 For, 1 Against and 1 Abstaining and is passed.
