Called to Order: 19:29

Past Minutes: The minutes from the July 14th meeting were emailed to the Board for their reading by the Secretary on October 13th. The Secretary motions to accept the minutes, seconded by Director Dave, carried.

Financial Report: The Treasurer reports that the current balance in the account is \$23,050.67. The Treasurer motions to accept the financial report, seconded by the Director Ed, carried.

Reports of Officers: Director Ed has nothing to report.

Director Dan reports that his venue inspections have been completed and hands in the paperwork to the Secretary.

Director Dave reports that his venue inspections have been completed and hands in the paperwork to the Secretary.

The Treasurer reports that there is a discrepancy with the singles registration fees collected from this year. After a lengthy discussion the situation is resolved due to a credit not issued correctly.

The President has nothing to report.

The Scorekeeper reports that he has \$80.00 in singles registrations and hands the paperwork in to the Secretary and the funds to the Treasurer. The Scorekeeper requests an internet usage cheque in the amount of \$90.00.

The Vice President reports that the lines at the Corp have now been sorted. The Vice President reports that the Clubhouse has indicated they cannot handle dart teams this year. After a discussion it is decided that the two teams there will need to be relocated and new venues are assigned to them.

The Secretary reports that he has player additions and substitutions as well as a team addition totaling \$855.00. The funds and the ledger sheet are handed to the Treasurer. The Secretary hands in staples receipts from printing totaling \$178.50 and requests a cheque for reimbursement

The Secretary advises that he will talk to the individuals that are going and will relay that information.

New Business: The Secretary starts a discussion regarding the Staples Card no longer being usable due to a carrier change with the company. A discussion occurs and it is decided that the Treasurer will approach the bank to see if a secured Visa is capable of being issued and will report at the next meeting.

The Scorekeeper starts a discussion regarding being approached by members of the ladies league asking about the possibility of joining the Men's Singles League. A discussion occurs and it is decided at this time that the league rules do not permit this at this time and that this may be discussed at a future meeting.
